

# Privacy-and cookie statement

Your privacy is very important for Travelcanyonblog.com. Therefore, we commit ourselves to the relevant laws and regulations about privacy, including the 'Algemene Verordening Gegevensbescherming (further on: AVG). This means that we:

- Clearly define our purposes, before we process your personal data, via this privacy statement;
- Store as little personal data as possible and only the data that is necessary for our purposes;
- Request explicit permission for the processing of your personal data, if permission is required;
- Take necessary security measures to protect your personal data. We also impose these obligations on parties who:  
process personal data for us;
- Respect your rights, such as the right to inspect, correct or delete your personal data processed by us.

Your data is safe with us and we will always use this data properly. In this privacy statement we explain what we at the company Travelcanyonblog.com do with information that we get from you.

### **Contact form**

With the contact form you can ask us questions or make requests. For this we use your:

- Name and address details
- Telephone number
- E-mail address

We do this on the basis of your permission. We keep this information until we are sure that you are satisfied with our response.

### **Location data**

Sometimes it is necessary for our company Reisjunk.nl to find out where you are. We then ask separately if we may know this and only if you give permission, we will receive this information.

For this service we use the navigation and location software on your phone, tablet or computer. We have no control over what the creators of this software (such as Google or Apple) do with it. So always read their privacy statements.

### **Provision to other companies or institutions**

With the exception of the parties necessary to provide the services mentioned above, we will under no circumstances give your personal data to other companies or institutions, unless we are legally obliged to do so (for example, if the police require this in the event of a suspicion of a crime).

### **Statistics**

We keep statistics about the use of our company, but this data is always anonymized. Social media buttons are included in our company. With this, the administrators of these services collect your personal data.

### **Cookies**

Our company uses cookies. Cookies are small files in which we can store information, so that you do not have to fill it in every time. But we can also see that you visit us again. You can disable the placing of cookies via your browser, but some things about our company will no longer work properly.

We have made agreements with other companies that place cookies about the use of cookies.

However, we do not have full control over what they do with the cookies themselves. So also read their privacy statements.

### **Security**

Security of personal data is of great importance to us. We ensure that your data is properly secured with us. We always adjust the security and pay close attention to what can go wrong.

### **Changes to this privacy statement**

When our company changes, we must of course also adjust the privacy statement. So always pay attention to the date above and check regularly for new versions. We will do our best to notify you of any changes.

### **Your rights**

If you have any questions or want to know what personal data we have about you, you can always contact us. If you have any questions or want to know what personal data we have about you, you can always contact us. See contact details below.

You have the following rights:

- Receive an explanation of what personal data we have and what we do with it;
- Access to the exact personal data we have;
- Having errors corrected;
- Having outdated personal data removed;
- Having personal data transferred to another party;
- Withdrawal of consent;
- Restrict certain processing;
- Object to a particular use.

Please note that you always clearly indicate who you are, so that we can be sure that we do not modify or delete data from the wrong person.

In principle, we will comply with your request within one month. However, this period may be extended for reasons related to the specific rights of data subjects or the complexity of the request. If we extend this period, we will inform you in good time.

### **Complaint**

If you feel that we are not helping you in the right way, you have the right to file a complaint with the supervisory authority. This is called the Autoriteit Persoonsgegevens (Dutch Data Protection Authority)
